Associated members do not have voting rights within BEAMA's governance.

## Full Membership

The annual contribution for full membership is relative to the **type and the size of the institution's activities** in Belgium.



## Associated Membership

The annual contribution for associated membership depends on **the volume of ISIN-codes** for which fund NAV and UCI communications are published.

The fund or the fund manager needs to inform us on the number of share classes involved.

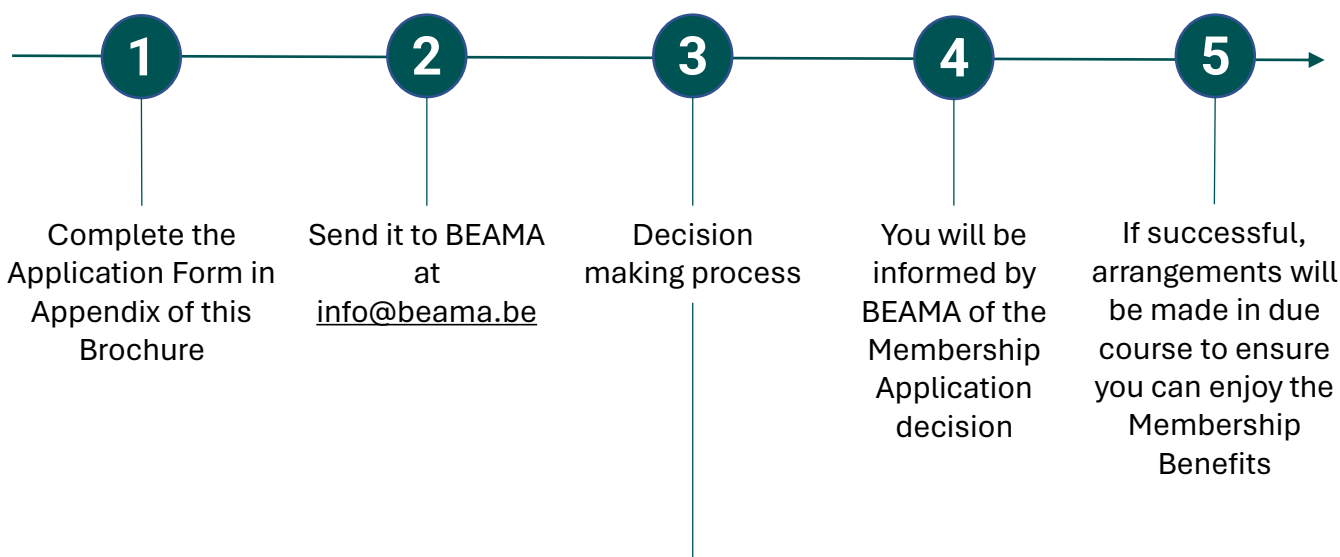
Our financial year ends on December, 31. If you become a Member in the course of the financial year, a **pro rata** contribution is calculated.

# HOW TO BECOME A MEMBER?

The Membership Application procedure is as follows:



Depending on the Membership type, the procedure is different

## Full Membership

Your Application will be handled at the next **Board of Directors** meeting. If the Board consents with the candidature, you become a **candidate-member**. You will already receive general information and can participate in working groups with observer status. Following a positive decision of the Board, a candidature for full membership will be put on the agenda of the **next General Assembly** - approval has to be given by 2/3 of the members. After this procedure you have full member status. The consultation of the General Assembly can be replaced by a written procedure when necessary. The time frame for this procedure is on average **6 - 8 weeks**.

## Associated Membership

Your Application will be handled at the next monthly **Board of Directors** meeting. If your candidature is compliant with the conditions of the requested Associated Membership that have been laid down by our past general assemblies in line with our bylaws and the **Board consents** with the candidature, you become an associated member.
